MESSAGE FROM THE STATE REGENT

Dear Sisters in Christ,

The grand finale of my term has come and gone and what an awesome convention it was. For those of you who were unable to attend, you definitely missed a big weekend to celebrate with your sister CDA members. Members from 176 courts from across Texas attended the 46th Biennial Texas State Convention in McAllen. There were 1032 registered members, fourteen clergy, and fifty-five guests and spouses present. There were 527 delegates and 108 alternates.

The beautiful liturgies set the tone for each of our days at the convention. We were spread across five hotels which I did not like, but we made it work. There were new things undertaken at this convention, but we preach change and looking for new ideas, so this was our chance to practice what we preach. We had a mini mall inside the convention center with the many vendors that were set up for your shopping; we had the full two screen projection of information for the entire convention, It has been several years since having Resolutions and Bylaws amendments proposed and voted on to send to the National Resolutions and Bylaws Committee, so we were excited about that. We had the passing of State Officers robes; had one person announcing all the Circle of Love awards; had District Deputies sitting with their districts; had a convention photographer; and had the First Walk/Run event to collect monies for the Texas charities. We all survived it, and most enjoyed all the changes.

I just received from National an updated membership roster, and our total membership count is 16,106! In September of 2008, the membership total was 15,654. It is the hard work of courts holding membership drives that has been keeping and will continue to keep Texas CDA above 16,000!

I want to express my sincere thanks for the gifts I received at the State Convention. Thanks to the State Officers for the beautiful gold cross and to the State's VIP's for the gold chain to hold my cross. I will wear them around my neck to have you close to my heart at all times. Thank you, as well, to the State VIP's for the cash and for my Garmin GPS that will always lead me back home to Texas. Finally, thank you to the courts and members for your generous contribution of cash that I will spend wisely.

When you receive this newsletter, your new State Officers will have taken office; so, please inform your local officers and the membership of the new names for each office. The new State Officers are listed in this newsletter.

It has been a wonderful eleven years that I have had the honor to serve all of you; the last two years as your State Regent were especially wonderful. I will carry the memories and love of all of you with me for the rest of my life.

May Dues & Assessments

The May state dues and assessments will be billed to each court a little late this year! The state’s server will be undergoing some maintenance and updating during the month of May. Please remember that state dues and national dues do not require a vote to be paid. Your billing will have the state dues of \$1.50 per member; \$1.00 per member for Theological Fund and \$.10 per member for JCDA whether you have a JCDA court or not.

Please remember to pay the dues and assessments as soon as you receive them. Write your court number on the check. Two (2) signatures are required per the National bylaw Article XIV, Section 3, page 42! Remember to also make the check payable to: **TEXAS STATE COURT**. The bills will be sent out from me, Peggy Rosales, Current State Secretary, but your checks will be sent to the **NEW STATE SECRETARY, EVE TREVINO** for processing and then on to the **NEW STATE TREASURER, MINNIE RODGERS** for deposit. Also, remember that if the dues are not received within 90 days of the **billing date** a \$5.00 late fee will be required.

The state officers will not be taking the summer off – so send the dues in!

- Provide copies of the State newsletter to ALL local court officers
- Involve new members in committees and projects
- New members recruited to co-chair activities with experienced members so they can learn what needs to be done and the following year, the “new” member serves as the chairman.

Subject: ALERT: OPPOSE FUNDING OF DESTRUCTIVE EMBRYONIC STEM CELL RESEARCH!

TO: State and Territorial Court Regents and Legislative Chairs
If only one of you has e-mail, please advise the other leader.

On April 22 we forwarded the press release of Cardinal Justin Rigali, Chairman of the Pro-Life Activities Committee, U.S. Conference of Catholic Bishops (USCCB), criticizing the draft guidelines for destructive stem cell research published by the National Institutes of Health (NIH).

A full campaign is underway by the USCCB urging everyone to write to their U.S. Senators and Congressman opposing the use of federal funds for stem cell research that requires destroying live human embryos, and to contact NIH.

Calling the guidelines "the first step," Representatives Diana DeGette (CO) and Michael Castle (DE) intend to move forward with broader legislation to "promote all forms of ethical stem cell research," which in their view includes cloning and the creation of embryos solely to destroy them.

Contacting the National Institutes of Health (NIH):

NIH should be contacted opposing their draft guidelines. **Comments to NIH must be received by them by May 26.**

Message to NIH: "I am opposed to your draft guidelines for embryonic stem cell research, which force me as a taxpayer to subsidize research requiring the destruction of innocent human life. Support should be directed to stem cell research and treatments that harm no one and are already producing good results. In no case should government support be extended to human cloning or other morally reprehensible creation of human embryos for research purposes."

Message to U.S. Senators and Congressman: "Do not use my tax dollars to promote destructive embryonic stem cell research or any form of human cloning. Instead please support adult stem cell research, which is ethically sound, harms no one, and is already producing treatments."
